

3. 'Oku fakatonutonu 'a e Tefito'i Lao 'aki hono tamate'i 'a e kupu 3 pea fetongi'aki 'eni:

"3. Ma'u Mafai Lahi ki he Laiseni

(1) Kuo pau ko e Ma'u Mafai Lahi ki he Laiseni te ne pule'i 'a e Lao ni.

(2) 'E ngofua ki he Ma'u Mafai Lahi ki he Laiseni, ke ne fokotu'u ha kau 'ofisa laiseni mo e kau 'ofisa faisivi mo ha kau 'ofisa kehe 'e pehe 'oku fiema'u koe'uhi ko hono ngaue'aki pe fakahoko 'o e ngaahi mafai, pule pe ngaahi fatongia kuo tuku pe hilifaki ki he Ma'u Mafai Lahi ki he Laiseni pe ko e Potungaue ke fakahoko 'a e ngaahi taumu'a 'o e Lao ni.

(3) 'E ngofua ki he Ma'u Mafai Lahi ki he Laiseni ke vahe'i 'i he tohi 'a e ngaahi mafai ko ia 'i he Lao ni ki he ni'ihi 'a ia 'e fiema'u ki hono fakahoko 'o e ngaahi kupu 'o e Lao ni pe ha Ngaahi Tu'utu'uni 'oku fa'u 'i heni."

4. 'Oku fakatonutonu 'a e kupu 6(2) 'o e Tefito'i Lao 'aki hono tamate'i 'a e "Kau Polisi" pea fakahu atu eni -

"Potungaue".

5. 'Oku fakatonutonu 'a e Tefito'i Lao 'aki hono tamate'i 'a e kupu 7(1) pea fetongi 'aki eni -

"7. (1) Kuo pau ki he taha kotoa 'oku 'o'ona ha me'alele ke kole ha laiseni me'alele ki he Ma'u Mafai Lahi ki he Laiseni 'i he ngaahi 'ofisi 'o e Potungaue 'i he Vahe 'oku nofo ai."

6. 'Oku fakatonutonu 'a e Tefito'i Lao 'aki hono tamate'i 'a e kupu 10(1) pea fetongi'aki eni -

"10. (1) 'I he 'aho 'e 7 mei hono fakatau atu pe tuku atu 'o ha me'alele kuo lesisita, kuo pau ki he taha 'oku ne fakatau atu pe tuku atu ia ke fakaha 'i he tohi ki he Ma'u Mafai Lahi ki he Laiseni 'i he ngaahi 'ofisi 'o e Potungaue 'i he Vahe 'oku lesisita lolotonga ai 'a e me'alele 'a e tuku atu pea mo e hingoa mo e tu'asila 'o e taha 'oku 'o'ona fo'ou."

## AN ACT

### TO AMEND THE TRAFFIC ACT TO TRANSFER MINISTERIAL AND ADMINISTRATIVE POWERS TO THE MINISTER OF TRANSPORT AND THE MINISTRY OF TRANSPORT

BE IT ENACTED by the King and the Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

1. (1) This Act may be cited as the Traffic (Amendment) Act 2008.
- (2) The Traffic Act (Cap 156), as amended, is in this Act referred to as the Principal Act.
2. Section 2 of the Principal Act is amended by -
  - (a) inserting after the definition of "mentally defective" the following definition -
 

" "Ministry" means the Ministry of Transport;"
  - (b) deleting the definition of "Police Officer" and replacing with the following -
 

" "Police Officer" means any member of the Police Force;"
  - (c) deleting the definition of "Principal Licensing Authority" and replacing with the following ;
 

" 'Principal Licensing Authority' means the Minister for Transport."
3. The Principal Act is amended by deleting section 3 and replacing with the following -

**"3. Principal Licensing Authority**

- (1) The Principal Licensing Authority shall be charged with the administration of this Act.
- (2) The Principal Licensing Authority may designate such licensing officers and examining officers and other officers as may be deemed necessary for the purpose of exercising or discharging the powers, authority or duties conferred or imposed on the Principal Licensing Authority or the Ministry to carry out the purposes of this Act.
- (3) The Principal Licensing Authority may delegate in writing such powers under this Act to such persons as may be necessary for the due carrying out of the provisions of this Act or any Regulations made hereunder."

4. Section 6(2) of the Principal Act is amended by deleting "police offices" and inserting the following -

"Ministry's offices".

5. The Principal Act is amended by deleting section 7(1) and replacing with the following -

"7. (1) The owner of every motor vehicle shall apply to the Principal Licensing Authority at the Ministry's office at the District in which he resides for a motor vehicle licence."

6. The Principal Act is amended by deleting section 10(1) and replacing with the following -

"10. (1) Within 7 days after the sale or other disposal of any registered motor vehicle the person selling or otherwise disposing of the same shall in writing notify the Principal Licensing Authority at the Ministry's office at the district where the motor vehicle is for the time being registered of the fact of the disposal and of the name and address of the new owner."

- (2) 'Oku ui heni 'a e Lao ki he Fe'alu'aki 'i he Hala (Vahe 156), 'i hono fakatonutonu, ko e Tefito'i Lao.
2. 'Oku fakatonutonu 'a e kupu 2 'o e Tefito'i Lao 'aki hono -
  - (a) fakahu atu hili 'a e 'uhinga'i 'o e "'atamai kovi" 'a e 'uhinga'i ko 'eni -
 

"Potungaue" 'oku 'uhinga ki he Potungaue ki he Fefononga'aki;"
  - (b) tamate'i 'a e 'uhinga'i 'o e "'Ofisa Polisi" pea fetongi'aki eni -
 

"'Ofisa Polisi" 'e 'uhinga ia ki ha memipa 'o e kau Polisi;
  - (c) tamate'i 'a e 'uhinga'i 'o e "'Ma'u Mafai Lahi ki he Laiseni" pea fetongi'aki eni -
 

"'Ma'u Mafai Lahi ki he Laiseni" 'oku 'uhinga ia ki he Minisita 'o e Fefononga'aki;"
