- (2) Ko e kaveinga ki he Uike Lao 2020 ko e "COVID-19 mo e Laó".

LAW WEEK 2020: "COVID-19 AND THE LAW"
12 November 2020

- (1) The Attorney General's Office wishes to inform the public that it will deliver Law Week 2020 from Sunday 15 November 2020 to Friday 20 November 2020.
- (2) The theme for Law Week 2020 will be "COVID-19 and the Law".
- (3) The objective of Law Week 2020 is to inform the public of the legislation and regulations that is applicable to COVID-19 and to identify the challenges and benefits we face in the application of these laws in Tonga and how the general public can work together to protect themselves of the risks of COVID-19.
- (4) This will be the thirteenth year that the Attorney General's Office has delivered Law Week.
- (5) Law Week will involve the following activities –
 - (a) Television program on Tonga Broadcasting Commission which will be aired on Monday 16 November 2020;
 - (b) Daily radio talkback shows on Radio Tonga from Monday 16 November 2020 to Thursday 19 November 2020; and
 - (c) Poster, Poem and Essay Competitions for different age groups on the theme "COVID-19 and the Law".
- (6) Members of the public are invited by the Attorney General's Office to contribute to these Law Week Programs and to encourage working together to ensure that the general public remains aware of ways to protect themselves of the risks of COVID-19.
