National Lockdown Notice Clarifications

The Minister responsible for Emergency Management in light of the National Lockdown Notice (“Notice”) issued by the Honourable Prime Minister dated **26 March 2020** wishes to provide these clarifications -

- (1) The “domestic public transportation” referred to in paragraph (6) of the Notice means the following –
 - (a) any other motor vehicle carrying passengers for hire or reward and includes a taxi (whether three wheeled or four wheeled) passenger bus and passenger lorry;
 - (b) ships as defined under section 2 of the Shipping Act [Cap 136]; or
 - (c) aircrafts as defined under the Civil Aviation Act 2014.

- (2) The liquor licences referred to in paragraph (7) of the Notice further includes the following licences -
 - (a) Wholesale Licence;
 - (b) Club Licence; and
 - (c) Special Events Licence.

- (3) The “kava clubs” referred to in paragraph (9) of the Notice means –
 - (a) a group of 2 or more people consuming kava at a public location; or
 - (b) a group of 2 or more people consuming kava at a private location.
 - (c) Paragraph (a) and (b) does not apply to people living in the same residential household.

Ngaahi Fakama'ala'ala 'o e Fakanongonongo Tapuni Fakataputapui

'Oku faka'amu 'a e Minisita 'oku ne tokangaekina 'a e Me'a Fakafokifa koe'uhi ko e Fanongonongo Tapuni Fakataputapui ("Fanongonongo") kuo tuku atu 'e he 'Eiki Palemia 'i he 'aho **26 Ma'asi 2020** ke 'oatu 'a e ngaahi fakama'ala'ala ko eni –

- (1) Ko e "ngaahi me'a feuta'aki kakai fakalotofonua" 'oku 'uhinga ki ai 'i he palakafi (6) 'o e Fanongonongo 'oku 'uhinga ki he ngaahi me'a ko eni –
 - (a) ha saliate misini kehe 'oku haea pe totongi 'oku ne uta ha kau pasese pea kau ki ai ha tekisi ('o tatau pe 'oku ve'e tolu pe ve'e fa), pasi uta pasese mo e loli uta pasese;
 - (b) ngaahi vaka 'i hono faka'uhinga' 'i he kupu 2 'o Lao ki he Folau Vaka [Vahe 136]; pe
 - (c) ngaahi vakapuna 'i hono faka'uhinga' 'i he Lao ki he Fefolau'aki Sivile 2014.
- (2) Ko e ngaahi laiseni kava malohi 'oku 'uhinga ki ai 'i he palakalafi (7) 'o e Fanongonongo 'oku toe kau atu ki ai 'a e ngaahi laiseni ko eni –
 - (a) Laiseni Fakakatoa;
 - (b) Laiseni Kalapu; mo e
 - (c) Laiseni 'o e Ngaahi Me'a Makehe.
- (3) Ko e "ngaahi kalapu kava tonga" 'oku 'uhinga ki ai 'i he palakalafi (9) 'o e Fanongonongo 'oku 'uhinga ki ha –
 - (a) kulupu 'o e kakai 'e toko 2 pe tokolahi ange 'oku nau inu kava 'i ha feitu'u fakapule'anga; pe
 - (b) kulupu 'o e kakai 'e toko 2 pe tokolahi ange 'oku nau inu kava 'i ha feitu'u taaoutaha;
 - (c) 'Oku 'ikai ngaue'aki 'a e palakalafi (a) mo e (b) ki he ni'ihii 'oku nofo 'i he 'api nofo'anga tatau.
