**National COVID-19 Restrictions (Tongatapu Vava'u Islands and Ha'apai Islands)  
(Exemption) Directions**


**IN EXERCISE** of the powers conferred by sections 37 and 39 of the Emergency Management Act [Cap 7.02], the Commissioner of Tonga Police and the Chief of Defence Staff of His Majesty's Armed Forces, as an authorised officer under section 36(2) of the Emergency Management Act, on the advice and recommendation of the Ministry of Health, hereby makes the following Directions –



Notwithstanding paragraph (6) of the **National COVID-19 Restrictions (Tongatapu, Vava'u Islands and Ha'apai Islands) Directions**, issued on 20 May 2022 –

- (1) These Directions shall be effective from Monday 30 May 2022 to Friday 3 June 2022.
- (2) All Early Childhood Learning Schools and Primary Schools located in the outer islands of Vava'u Island and Ha'apai Island shall operate.
- (3) These Directions shall only apply to the outer islands of Vava'u Island and Ha'apai Island.
- (4) All persons shall observe and promote social distancing at all times and shall wear a mask at all times.

(Tongatapu , 'Otumotu Vava'u mo e 'Otumotu Ha'apai)**

**'I HONO NGAUE'AKI** 'o e ngaahi mafai kuo foaki 'i he kupu 37 mo e 39 'o e Lao ki hono Pule'i 'o e Ngaahi Me'a Fakafokifa [Vahe 7.02], 'oku fa'u ai 'e he Komisiona 'o e Polisi Tonga mo e 'Eikitau 'o e Kau Tau 'a 'Ene 'Afio 'i hono tu'unga ko e 'ofisa fakamafai 'i he kupu 36(2) 'o e Lao ki hono Pule'i 'o e Ngaahi Me'a Fakafokifa, hili hono ma'u 'a e fale'i mo e fokotu'u mei he Potungae Mo'ui, 'a e Ngaahi Tu'utu'uni ko 'eni –

Neongo 'a e **Ngaahi Fekau Fakangatangata Fakafonua ki he COVID-19 (Tongatapu, Vava'u mo Ha'apai)** na'e fakahoko 'i he 'aho 20 'o Mē 2022 –

- (1) Kuo pau ke kamata ngaue'aki 'a e Ngaahi Tu'utu'uni ko 'eni mei he 'aho Monite, 30 'o Mē 2022 ki he Falaite, 3 'o Sune 2022.
- (2) Kuo pau ke ngofua ke kamata ngaue 'a e ngaahi 'apiako ma'ae fanau iiki mo e ngaahi 'apiako lautohi 'oku tu'u 'i he ngaahi 'otumotu 'i Vava'u mo Ha'apai
- (3) Kuo pau ke ngaue'aki 'a e Ngaahi Tu'utu'uni ni ki he ngaahi 'otumotu 'i Vava'u mo Ha'apai.
- (4) Kuo pau ke talangofua mo fakahoko 'e he taha kotoa 'a e vā mama'o fakaetangatá 'i he taimi kotoa pē pea kuo pau ke ngaue'aki 'a e naunau malu'i fofonga 'i he taimi kotoa.
