‘I HONO NGAUE’AKI ‘o e ngaahi mafai kuo foaki ‘i he kupu 37 mo e 39 ‘o e Lao ki hono Pule’i ‘o e Me’a Fakafokifa [Vahe 7.02] (‘o e “Lao ni”), ‘oku fakahoko ai heni ‘e he Komisiona ‘o e Polisi Tonga Le’ole’o mo e ‘Eikitau ‘o e Kau Tau ‘a ‘Ene ‘Afio, ‘a ia ko e ongo ‘ofisa fakamafai ‘i he kupu 36(2) ‘o e Lao ni, ‘a e ngaahi fekau ni –

(1) ‘Oku tapui ‘a e kakai ‘o e fonua ‘o kamata mei he 8.00 pongipongi ‘o e Sapate 10 ‘o ‘Epeleli 2022 ki he 8.00 pongipongi ‘o e Sapate, 8 ‘o Mē 2022 mei he hū ki –

- (1) Kanokupolu, Vahenga Hihifo, Tongatapu;
- (2) ‘Atata, Vahenga Hihifo, Tongatapu;
- (3) Tofi’a Pule’anga ko Patangata mo Nukunukumotu;
- (4) Tofi’a Pule’anga ko Fafaa, Tongatapu;
- (5) Tofi’a Pule’anga ko Makaha’a, Tongatapu;
- (6) Pangaimotu, Faka-Tokelau ‘o Nuku’alofa, Tongatapu;
- (7) Mango, Vahenga Mu’omu’a, Ha’apai,

mo e ngaahi ‘elia ‘a ia ‘oku faka’ilonga’i ‘aki ‘a e ngaahi laine le’ohi ‘ehe kau polisi mo e kau sotia mo e ngaahi vahevahe mo e tapuni ‘i he hala ‘o takai ‘i he ngaahi feitu’u ‘oku ha ‘i ‘olunga.

(2) Koe’uhi ke ‘oua ‘e ‘i ai ha tala’a, ‘oku ‘ikai ngaue’aki ‘a e palakalafi (1) ‘i ‘olunga ki he –

- (1) kau ‘ofisa fakamafai ‘i he kupu 36 ‘o e Lao ki hono Pule’i ‘o e Me’a Fakafokifa; mo e
- (2) ni’ihi ‘oku nau nofo ‘i he ngaahi ‘elia ‘oku fakamahino ‘i he palakalafi (1) ki he (6) mo Ha’atafu.

RESTRICTIONS DIRECTIONS

IN EXERCISE of the powers conferred by sections 37 and 39 of the Emergency Management Act [Cap 7.02] (“the Act”), the Acting Commissioner of the Tonga Police and the Chief of Defence Staff of His Majesty’s Armed Forces, as authorised officer under section 36(2) of the Act, hereby make the following directions –

(1) Commencing from 8.00am on Sunday 10 April 2022 until 8.00am on Sunday 8 May 2022, members of the public are prohibited from entering the following areas -

- (1) Kanokupolu, Hihifo District, Tongatapu;
- (2) ‘Atata, Hihifo District, Tongatapu;
- (3) Patangata and Nukunukumotu Government Estate, Tongatapu
- (4) Fafaa, Government Estate, Tongatapu
- (5) Makaha’a, Government Estate, Tongatapu;
- (6) Pangaimotu, North Nuku’alofa, Tongatapu; and
- (7) Mango, Mu’omu’a District, Ha’apai,

and any areas defined by marked police and military cordon lines and road blocks around the above named areas.

(2) For the avoidance of doubt, paragraph (1) above does not apply to –

- (1) authorised officers under section 36 of the Emergency Management Act; and
- (2) a person who currently domiciles in areas identified in paragraph (1) to (6) and Ha’atafu.
