**CONSUMPTION TAX ACT 2003
(Section 5(3)(a))**

ORDER

IN EXERCISE of the powers conferred by section 5(3)(a) of the Consumption Tax Act 2003, the Minister for Revenue and Customs, with the approval of Cabinet, makes the following Order -

That the goods imported from China by the Beijing Machinery Repair Company Limited ("BMRCL") through the Investment Cooperation Contract between the Ministry of Agriculture, Food, Forest and Fisheries ("MAFFF") and BMRCL for the following purposes-

- (i) agricultural machineries for farm land preparation, crop cultivation, harvest and value addition including tractor and ploughing equipment that will be used by this project for the development of the agriculture sector;
- (ii) machinery, mechanical equipment and spare parts to equip the Machinery Pool to effectively carry out the repair and maintenance of agricultural machineries; and
- (iii) steel and timber construction materials for the reconstruction of Machinery Pool old buildings, some of which were damaged by Tropical Cyclone Gita in February 2018.
