ORDER

IN EXERCISE, of the powers conferred upon me by section 11(4) of the Magistrate’s Court Act, I hereby invest Lata ‘I Manamo’ui Kaufusi, Senior Magistrate, with the power to hear and determine, with consent of the prosecution and the defendant, and in accordance with section 35 or 36 of the Magistrate’s Court Act, criminal cases where the maximum punishment imposed will not exceed seven years imprisonment or a fine of \$50,000.00.

The power hereby invested shall commence from 24th January, 2024, and, unless beforehand renewed, shall expire 2 years from such date of commencement.
