- (3) 'Oku faka'atâ mei he tuhau ngaue'aki 'a e ngaahi naunau ngaue mo e me'angaue kuo hu mai 'a ia 'oku mahu'inga ki hono fakanaunau 'a e Fale Sivi ki he Tu'unga 'o e Vai 'a e Poate Vai 'o Tonga; pea
- (4) Kuo pau ke kei ngaue'aki 'a e ngaahi faka'atâ ko 'eni ki ha vaha'a taimi ko e mahina 'e 12; pea

## CONSUMPTION TAX ACT [CAP.11.01]

## (Section 5(3)(a))

## ORDER

**IN EXERCISE** of the powers conferred by section 5(3)(a) of the Consumption Tax Act [Cap. 11.01], the Minister responsible for revenue and customs, with the approval of Cabinet makes the following Order –

- (1) That the imported equipment and materials for the completion of the Tonga Water Board Solar Farm Project and its associated Water Network Management Systems, be exempted from consumption tax; and
- (2) That the imported equipment and materials for the completion of the Tonga Water Board Demonstration Project Installation on Nomuka Island, be exempted from consumption tax; and
- (3) That the imported tools and equipment crucial for the furnishing of the Tonga Water Board Quality Laboratory, be exempted from consumption tax; and
- (4) That these exemptions shall remain in force for a term of 12 months; and
- (5) That this Order shall come into force on the date of gazettal.
