CONSUMPTION TAX ACT [CAP. 11.01]

(Section 5(3)(a))

ORDER

IN EXERCISE of the powers conferred by section 5(3)(a) of the Consumption Tax Act [Cap. 11.01], the Minister responsible for revenue and customs, with the approval of Cabinet makes the following Order –

- (1) That the imported goods for Tonga Renewable Energy Project (TREP) 3, Lot 2, funded by the Asian Development Bank in accordance with the signed correspondences and the implementation agreement, be exempted from consumption tax; and
- (2) That the Orders coming into effect will apply to consignments imported in accordance with the Agreement between Ministry of Meteorology, Energy, Information, Disaster Management, Environment and Climate Change and Communications (MEIDECCC) and Infratech NET con JV; and
- (3) That these exemptions are valid until the 31st of July 2024; and
- (4) That this Order shall come into force on the date of gazettal.

IN EXERCISE of the powers conferred by section 3 (1)(b) of the Customs Act [Cap. 11.02], the Minister responsible for revenue and customs, with the approval of Cabinet makes the following Order –
